


MINUTES & DECISIONS

- Discussion was done on the tactics to prevent ragging in the institution

- Faculty members were instructed to maintain **vigilance and regular monitoring**, particularly during the initial weeks of the academic session.
- The committee members will undertake **regular inspections** of corridors, and other common areas to prevent any untoward incidents.
- The Chairperson emphasized that **any violation of anti-ragging regulations shall attract strict disciplinary action** in accordance with institutional policies and UGC guidelines.
- The next meeting of the committee will be scheduled to review the compliance, report of inspections, and the status of any complaints received.
